NOTIFICATION

G.O. (P) No. 12/93/PW&T. *Thiruvananthapuram, 15th February 1993.*

S. R. O. No. 278/93.—Whereas the Central Government have by Notification S. O. 701 (E) dated the 12th September, 1990 directed the State Government under clause (a) of sub-section (3) of section 71 of the Motor Vehicles Act, 1988 (59 of 1988) to direct the State Transport Authority and the Regional Transport Authorities concerned to limit by notification in the Official Gazette, the number of Stage Carriages operating as City Services in the places in the State specified therein.

Now, therefore, in pursuance of the said direction, having regard to the number of vehicles operating in the area, road conditions and other relevant matters, and in supersession of the Notification No. G.O. (P) 64/91 dated the 30th August, 1991 published as S. R. O. No. 1110/91 in the Gazette dated 30th August 1991, the Government of Kerala hereby direct the Regional Transport Authorities concerned to limit the number of Stage Carriages operating on the City routes in the cities of Kozhikode and Kochi as fixed and specified in the Table below :—

Ten percent of the total number of permits in respect of stage carriages as fixed above shall stand reserved for Scheduled Castes and Scheduled Tribes and the quota so reserved shall be filled up by allotting one in every ten permits sanctioned, subject to the condition contained in the proviso to rule 146 of the Kerala Motor Vehicles Rules, 1989.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Clause (a) of sub-section (3) of section 71 of the Motor Vehicles Act, 1988 provided that the State Government shall, if so directed by the Central Government having regard to the number of vehicles, road conditions and other relevant matters, by notification in the Official Gazette, direct a State Transport Authority and Regional Transport Authority to limit the number of stage carriages generally or of any specified type as may be fixed and specified in the notification, operating on any City routes in Town with a population of not less than five lakhs. Accordingly, the recommendations of the State Government were invited by the Central Government in respect of cities in the States where the States would like to limit the number of stage carriages. On the basis of the information received from the State Government, the Central Government have in notification S. O. 701 (E)

dated 12-9-1990 directed to limit the number of stage carriages operating in the city routes in the cities of Kozhikode and Kochi. Under rule 146 of Kerala Motor Vehicles Rules when the number of stage carriages are fixed under clause (a) of sub section (3) of section 71 of the Act, 10% of the vacancies available shall be reserved for Scheduled Caste and Scheduled Tribes and the quota so reserved shall be filled up by allotting one in every 10 permit sanctioned. Having regard to the number of vehicles operating in the areas, the road conditions and other relevant matters such as the length of the roads available for operation in the place of Commercial, Industrial or Government importance of the place, the other means of conveyance in the place, etc. Government of Kerala consider it expedient to limit the number of stage carriages operating on city routes in the above two places. Hence the Notification.
