Order No. E3/244/2022-TC Dated. **16-03-2024**

As per the paper 1st read above, Transport Commissioner's squad was constituted authorizing to conduct Super Check in sub offices of the department with statewide jurisdiction. The above officers are authorised to conduct **Super Check** in the following duties of Motor Vehicle Department throughout the state of Kerala.

- 1.Test for Certificate of fitness.
- 2.Driving Test.
- 3.Vehicle Dealership activities.
- 4.Driving Schools.
- 5.Pollution Testing Centres.

If any irregularities detected, the officers are empowered to issue stop memo to the concerned and report it to Transport Commissioner. All RTOS & Joint RTOS shall give assistance to the said officials if requested and to act accordingly. The institutions that are received stop memo by the team shall only allowed to reopen after getting permission from Transport Commissioner. The team members are eligible for TA & DA while on tour.

All the officers are hereby directed to submit the details of the vehicle in the prescribed proforma with exterior and interior photographs of the vehicle to any of the above officers. Those vehicles whose CF cancelled through "Operation Focus 3" should complete the inspection by the registering authority. The officer who inspected for CF should send the details through Google Spreadsheet circulated through the Whats App group named "Team MVD". All Heads of offices are directed to provide vehicle and driver as and when required by the Transport Commissioner's squad for their work. The immediate controlling officer of this squad will be Shri. Saji Prasad, Deputy Transport Commissioner, Central Zone-II, Ernakulam.

Cancellation of Fitness of vehicles:

There is a direction given to the officials to inspect the contract carriages for unauthorised alteration, other unauthorised fitments and lights. Also, direction was given to cancel the certificate of fitness for those vehicles having the above. But it came to know that some officers hesitate to issue CFX highlighting a reason that cancellation of fitness can only be done under Sec 56 - 4(b) after conducting test Automated testing stations. As automated testing stations are not being started till now there is no need to test a vehicle to be tested in an Automated testing stations for the purpose of cancellation of fitness.

The Certificate of fitness of Transport vehicles shall be cancelled after issuing fitness if the following irregularities are detected

1. Speed Governor Disconnected / Tampered / If not set in prescribed speed

2. If the vehicle fitted with the tyres other than in the registration records
3. Emergency Exit blocked by seat or locked by any other mechanisms
4. If the bus body doesn't complies with AIS 052 Bus Body Code for the vehicles registered after 01/10/2017
5. If the vehicle having un authorised Head lamps, Roof lights, Blinking lights, Dance/Glass floor, Unauthorised wiring system used for high power audio system producing loud noise&DJ rotating LED Lights/Laser/Neon Light systems, Smokers,Fogging Equipment's, Water Spray Equipment's, Donkey Engines for the purpose Air Conditioning systems etc.
6. If the above irregularities are detected CFX shall be issued and the CF shall be cancelled with immediate effect. This CF cancellation shall be done at the concerned office itself by fetching the data from the concerned registering authority. After cancellation of CF the data shall be pushed to the concerned registering authority.
7. STA have decided to implement uniform colour code to new contract carriages w.e.f 01/06/2022 &from the date of renewal of certificate of fitness for old vehicles. So CFX/CF cancellation shall be issued for those vehicles who does not comply with the colour code for those vehicles who have registered or fitness issued only after 01/06/2022.

Also I hereby direct all to fill the prescribed proforma while inspecting the contract carriage vehicles for certificate of fitness and shall sent a copy to the above team.
