ORDER

- 1. As per the Government order read as 1st paper above, Administrative Sanction was accorded to the Transport Commissioner for an amount of Rs.6.42 crore, for setting up of control rooms and development of required software for monitoring of GPS fitted vehicles, during the financial year 2014-15.
- 2. As per the direction of the Technical Committee constituted for finalization of technology and road map for the implementation of GPS based vehicle tracking system in the state, M/s C-DAC Ltd submitted a proposal for the installation of control room and development of software for monitoring of 16000 stage carriages of the State.
- 3. As per the Government order read as 2nd paper above sanction was accorded to the Transport Commissioner for entrusting the project implementation of GPS based vehicle tracking system to M/s C-DAC for a total amount of Rs.6,41,50,673/-.
- 4. As per the Agreement executed between the Motor Vehicles Department and C-DAC, C- DAC has to complete the project within

one year and the payment has been scheduled in 5 installments by the achievement of each milestone.

- 5. At the end of the financial year 2014-15, the non-utilized funds for the said project were parked in the Electronic Ledger Account maintained by Finance Dept. with validity upto 30/09/2015. From the available funds posted in Electronic Ledger Account(ELAMS No.293/15), an amount of Rs.1,28,30,000/- was released to the Transport Commissioner towards the payment of 2nd installment to M/s C-DAC as per the Government order read as 3rd paper above.
- 6. Since the validity of e- Ledger account has expired on 30/09/2015, the Transport Commissioner as per his letter read as 4th paper above requested to accord sanction to release an amount of Rs.1,92,45,000/- (balance 3 installments as per payment schedule) from current year's (2015-2016) budget provision, for making payment to M/s C-DAC.
- 7. Government have examined the matter in detail and are pleased to accord sanction to the Transport Commissioner to release an amount of Rs.1,92,45,000/-(Rupees One Crore Ninety two lakh Forty five thousand only), being the balance payment of 3 installments to M/s C-DAC for the project GPS based vehicle tracking system sanctioned during 2014-15 financial year, subject to the correctness of the claim duly verified by the Transport Commissioner. The expenditure shall be debited to the Head of Account 5055-00-800-91(P) under the current year's (2015-16) budget provision.
