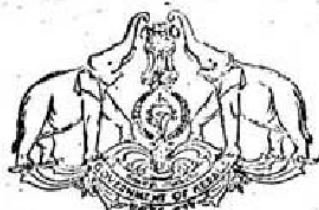

### NOTIFICATION

No. CI-16658/TC/94.

20th April 1995.

Under Rule 41 of KMV Rules 1989 and in Supersession of the notification No. CI-14912/TC/91 dated 5th October, 1992 published as S. R. O. No. 2024/93 in the Gazette dated 7-12-1993 the Transport Commissioner, Kerala hereby specifies that the driver of Transport Vehicles shall wear Pants and Shirts in Khaki Cloth. The Women drivers of the Ladies Autos shall wear either a Pant and Shirt in Khaki Cloth or a Cont in Khaki Cloth over their normal dress while driving the Autoricksaw.

Provided that the Indian Oil Employees who are designated as "Tank Truck Drivers" and driving the vehicle owned by the Indian Oil Corporation shall wear Pants and Shirts, in Grey Colour. This notification will take effect from the date of publication.

### Explanatory Note

(This does not form part of the notification but is intended to indicate its general purport.)

Rule 41 of the KMV Rules 1989 empowers the Transport Commissioner to specify the uniform to be worn by the drivers of Transport Vehicles. The notification No. CI-14912/TC/91 dated 5-10-1993 issued in this connection is not formally in order. The said notification should have been issued as one issued by the Motor Vehicles Department under the authority of Transport Commissioner without the captions Government of Kerala Public Works and Transport Department. Government have directed to issue fresh notification superseding the notification dated 5-10-1993.

In the meantime the State Level Co-ordinator, Indian Oil Corporation, Cochin has requested to exempt their employees who are designated as Tank Truck Driver and driving the Vehicle owned by the Indian Oil Corporation from wearing the Khaki Uniform since the corporation has already prescribed uniform in Grey Colour as per the agreement between the Management and the employees. Government have decided to exempt them from wearing the Khaki Pants.

This notification is intended to achieve the above objects.
