KERALA SERVICE RULES—10TH PAY REVISION—PROMOTION FROM TIME BOUND HIGHER GRADE TO REGULAR PROMOTION POSTS—FIXATION OF PAY—OPTION GRANTED—ORDERS ISSUED.

ORDER

As per Government Order read as 1st paper above the scales of pay of State Government employees and teachers have been revised with effect from 1-7-2014 and the facility of option allowed for fixation of pay under Rule 28 A Part I Kerala Service Rules has been withdrawn with effect from 1-2-2016. Prior to the revision, the posts of Junior Superintendent (HG) and Senior Superintendent were on the same scale of pay of ₹ 18740-33680. Therefore those who were in the 4th time bound higher grade post equivalent to the post of Junior Superintendent (HG) were eligible for fixation only under Rule 30 Part I Kerala Service Rules on promotion to the post of Senior Superintendent. But in the 10th Pay Revision, the scale of pay of Junior Superintendent (HG) has been revised to ₹ 35700-75600 and that of Senior Superintendent to ₹ 36600-79200. As per the Government Order read as 2nd paper above it had been clarified that in the case of an officer promoted or appointed by transfer to a post, which is not equivalent to the time bound higher grade enjoyed by him and carries lower, same or higher scale of pay fixation of pay will be made under the appropriate rules of fixation of pay in Kerala Service Rules. In view of this, those who are in the 4th time bound higher grade post equivalent to the post of Junior Superintendent (HG) in the scale of pay of ₹ 35700-75600 on promotion to the next promotion post of Senior Superintendent (the fifth level promotion of the post of Clerk) in the scale of pay of ₹ 36600-79200 during the period from 1-7-2014 to 31-1-2016 will be eligible for fixation of pay under Rule 28A Part I Kerala Service Rules. Option for fixation of pay under Rule 28 A Part I Kerala Service Rules has to be exercised by the officer within one month from the date of order of promotion or of taking charge in the promoted post whichever is later. But the time limit prescribed under the Rule cannot be followed in this case as the situation was changed due to Pay Revision.

2. Government have examined the matter in detail and are pleased to order that the pay of those who were promoted, during the period from 1-7-2014 to 31-1-2016, from the time scale of the 4th time bound higher grade equivalent to the post of Junior Superintendent (HG) on ₹ 35700-75600 to the post of Senior Superintendent/equated categories on ₹ 36600-79200 will be fixed under Rule 28A Part I Kerala Service Rules. They will be allowed to exercise option for fixation of pay under Rule 28A Part I Kerala Service Rules within a period of three months from the date of this order in relaxation of the time limit prescribed therein.
