Sir/Madam.

As you are aware, the Unique Identification Scheme is a Government of India's initiative for providing identity to all residents in India. The Unique Identification Authority of India (UIDAI) is entrusted with the responsibility of issuing UID numbers (Aadhar Numbers) and, among others, to define usage and applicability of the Aadhar numbers for delivery of various services.

- 2. As per d.o. letter dated 25th April, 2011 received from the then Cabinet Secretary, Government of India, Shri K.M. Chandrasekhar, UIDAI has commenced issue of Aadhar numbers and they can be treated as valid Proof of Identity (PoI) and Proof of Address (PoA). In this regard the Committee of Secretaries (COS) took a decision in the meeting held on 21st December, 2010 to integrate Aadhar numbers with central Government Schemes/Programmes.
- 3. As per Central Motor Vehicle Rules, 1989, there is a provision for producing evidence of address and age for obtaining a driving license (Rule 4 of CMVR, 1989) and proof of address for registration of vehicles (Rule 47 (1)(e) of CMVR, 1989) such as Electoral Roll, Life insurance Policy, Passport, Pay slip issued by any office of the Central Government or a State Government or a local body, School certificate, Birth certificate, Certificate granted by a registered medical practitioner not below the rank of a Civil Surgeon, as to the age of the applicant, any other document or documents as may be prescribed by the State Government under clause (k) of section 28 and proof of legal presence in India in addition to proof of residence in case of foreigners etc.
- 4. In order to ensure the utility and importance of Aadhar numbers and to integrate Aadhar numbers with central Government Schemes/Programmes, it is requested that appropriate instructions/directions may be issued to all transport offices under your

administrative control to recognise Aadhar as Proof of Identity (Pol) and Proof of Address (PoA) for evidence of age and address for obtaining a driving license and proof of address for registration of vehicles.
