Method of appointment

- (i) By promotion from the categories of Senior Superintendent/Senior Superintendent (Accounts)
- (ii) In the absence of qualified hands under item (i) above by transfer from the category of Junior Superintendent.

Qualifications:

- (i) A Pass in Accounts Test (Higher)
- (ii) A minimum service of ten years in the Motor Vehicles Department.
- (iii) Must have at least 5 years experience in Accounts and Finance matters of Government.

The Senior Superintendent or in the absence of the same, Junior Superintendent who possess the above qualifications are requested to submit their options, in the specimen form appended for appointment to the post of Accounts Officer. The options should be submitted through their Head of Office duly countersigned. The options should reach the head office within seven days on receipt of this letter. If the options are not submitted within the prescribed time it will be presumed that they are not willing to appointed to the post of Accounts Officer and they will not have any chance for option. Belated options will not be entertained on any account.
