ORDER

As per the letters read as 2nd and 3rd paper above ,the Transport Commissioner had recommended to create 529 posts in the Ministerial and Executive Wings and to create 86 posts of Drivers in the Motor Vehicles Department considering the abnormal increase in the number of vehicles and the consequential workload. Based on the recommendation of the Empowered Committee constituted as per Government Order read as 1st paper above, sanction was accorded for the creation of 55 post of Motor Vehicles Inspectors in the scale of pay of Rs.20740-36140 in the Motor Vehicles Department, ie, one additional post of Motor Vehicle Inspector to each Sub Regional Transport Office (55 Nos) for ensuring a more effective enforcement mechanism.

Regarding the creation of the remaining posts proposed by the Transport Commissioner in his letters read as 2nd and 3rd papers above Government have examined the matter further.

The Empowered Committee met on 2.3.2013 recommended to create the following 206 additional posts in the Motor Vehicles Department subject to the condition that the existing 40 posts (39 post of Typist and one post of Roneo Operator) in the Motor Vehicles Department would be declared supernumerary and that the e-payment facility shall be effectively implemented in all the districts within two months.

Orders on the distribution of the additional posts created above will be issued separately.


