All Regional Transport Officers are directed to take immediate action for the appointment of Drivers on daily wage basis and it shall be made from the list obtained from the Employment Exchange concerned. The Regional Transport Officer shall make the appointment for Sub Regional Transport offices under their control also. Remuneration shall be paid only at the rate fixed by Government vide G O No: 313/2006/Fin dated: 27/07/2006 & GO (P) No: 80/07/GED dated: 19/04/2007. The services of the persons selected shall be terminated on completion of 179 actual working days. Further appointments shall be made only from fresh list obtained from the local Employment Exchange. An Interview Board comprising the Deputy Transport Commissioner concerned (Chairman), RTO, and the one MVI shall be constituted and the selection of suitable candidate for deployment at Regional Transport Office/ Sub

Regional Transport office from among the list of persons furnished by the Employment Exchange shall be made on the recommendation of the Interview Board. The daily wage driver shall not <sup>be</sup> put in charge of the vehicle detailed for Mobile Enforcement Squad.


