This petition again coming on for petition and the affidavit filed in support of WP(C) and orders upon perusing the 24.01.2019 this Court's M/S T.R.HARIKUMAR, ADITHYA RAJEEV, ARJUN RAGHAVAN & and arguments Advocates for the petitioner , SRI. M. SASINDRAN, Advocate for the of respondents 1 & 2 and of GOVERNMENT PLEADER for Respondents 3 to 5, the court passed the following:-

ORDER

The order of this Court dated 24.01.2019 reads thus;

"The documents produced as Exts.P11 and P12 along with I.A. No.3 of 2019 are photographs of a Bolero jeep bearing registration No.KL-21/K-1321 owned by Vamanapuram Service Co-operative Bank, which is a Society registered under the Kerala Co-operative Societies Act, 1969 and the Rules made thereunder.

- 2. A Co-operative Society is not a statutory body. As held by the Apex Court in Executive Committee of Vaish Degree College, Sharnli v. Lakshmi Narain [1976) 2 SCC 58], there is a well marked distinction between a body, which is created by the Statute and a body, which after having come into existence, is governed in accordance with the provisions of the Statute.
- 3. A perusal of Exts.P11 and P12 photographs would show that the vehicle owned by the Society is fitted with a name board in red background. The said name board, which is fitted on a crash guard, obstructs clear view of the registration plate, which has to be exhibited in a motor vehicle as per the mandate of Rules 50 and 51 of Central Motor vehicle Rules, 1989 read with Regulation 36 of the Motor Vehicle (Driving) Regulations, 2017, issued by the Central Government, in exercise of its powers under Section 118 of the Motor vehicles Act, 1988.
- 4. By order dated 18.01.2019, the learned Senior Government Pleader was directed to make available for

the perusal of this Court the relevant circulars/Government order, if any, regarding purchase of vehicles by the Co-operative Societies and the norms and guidelines for its use. The learned Senior Government Pleader seeks further time to place on record the relevant circulars/ Government order and to address arguments with reference to the relevant provisions under the Motor Vehicles Act and the Rules made thereunder.

- 5. The learned counsel for the petitioner would submit that a reply affidavit to the counter affidavit filed by the 2^{nd} respondent shall be placed on record by 28.01.2019."
- 2. Pursuant to the aforesaid order, the learned Senior Government Pleader has made available for the perusal of this Court Circular No.32/2001 dated 17.08.2001 and Circular No.55/2003 issued by the 4th respondent Registrar of Co-operative Societies.
- 3. The learned counsel for the petitioner, after referring to the counter affidavit filed by the 2nd respondent in I.A.No.3 of 2019, would point out that, as per the entry made in Ext.R2(f) log book of Bolero jeep bearing registration No.KL-21/K-1321, the Convener of the Administrative Committee used the said vehicle on 20.11.2018 for travelling from Vamanapuram to the office of the Assistant Registrar of Co-operative Societies at Nedumangad. The learned

counsel would submit that 20.11.2018 was a public holiday (Milad-i-Sherif).

- 4. Along with the reply affidavit filed in I.A.No.3 of 2019, the petitioner has produced Ext.P15 photograph, in order to show that the vehicle is being parked in the residence of the Convener of the Administrative Committee for his personal activities.
- The learned counsel for respondents 1 and 2 seeks a short time to file an affidavit, explaining the facts and circumstances.
- 6. The learned Senior Government Pleader shall get instructions from the 4th respondent Registrar of Co-operative Societies, with specific reference to the materials referred to hereinbefore and the steps, if any, taken to prevent misuse of the vehicles owned by Co-operative Societies, by the office bearers of those Societies, and also the action, if any, taken against exhibition of unauthorised name plates with red background or blue background in the vehicles owned by Co-operative Societies.
