Sir,

Please refer to your letter dated 25.01.2017 requesting for extension of permission for road trials.

2. In this regard, this Ministry conveys the approval of the competent authority under Section 52 of the Motor Vehicles Act, 1988 for registration and trial run of vehicles across the country, for a period of one year subject to the following conditions:

- b) Such trial would be conducted without changing the power train. or engine management system of the vehicle.
- (b) No OEM fitted parts of the vehicle would be removed.
- (c) The vehicles would conform to its approved load bearing capacity and specifications.
- (d) The trial would be conducted all over the country for a period of one year only.
- (e) M/s Altigreen Propulsion Labs Private Limited would specifically intimate the registration number of the vehicles used for this purpose to the Principal Secretaries (Transport) and Transport Commissioners of the concerned States before conducting the trial and submit regular reports to Transport Authorities for their perusal.
- (f) The road trials should be done under the overall supervision of ARAI, Pune and iCAT Manesar.
- (g) Altigreen need to approach the office of Transport Commissioners of the States for registration of the vehicle.

Sub: Request for extension of permission for road trials


