ORDER

As per Section 33 of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 every appropriate Government shall appoint in every establishment such percentage of vacancies not less than three per cent for persons or Class of persons with disability of which one per cent each shall be reserved for persons suffering from (i) blindness or low vision, (ii) hearing impairment, (iii) locomotor disability or cerebral palsy in the posts identified for each disability.

As per G. O. read as 2nd paper above, the Government have already issued orders in supersession of all earlier orders in the matter and identified posts in Group B categories as suitable for appointment of physically disabled person in various Government Departments.

As envisaged in the section 32 of the Act, Government have reviewed the list of posts identified and added more posts as suitable for the appointment of persons with disability. Accordingly, the Expert Committee constituted for the purpose of identifying and recommending suitable posts for the appointment of persons with disability against the 3% reservation quota, in its meeting read as 4th and 5th paper above had reviewed the list of such posts and submitted their recommendation by identifying more posts under Group B as suitable for physically disabled.

Government have examined the recommendations of the Expert Committee in detail and are pleased to approve the recommendations as such and the following posts are also included in the lists of posts suitable for appointment of physically disabled persons in Group B.

List of categories of posts under Group B which are identified as suitable for appointment of physically disabled candidates.
