Consequent on the introduction of direct payment of taxes at the cash counters of the various offices of this department by dispensing with the payment of taxes via Demand Drafts, quantum of cash transactions in the various Regional/Sub Regional Transport Offices of this department are considerably increased, which requires support of the electronic devises for counting of notes and detection of fake notes. Accordingly, proposal for the purchase of the articles have been obtained from *M/s* Infres Methodex Limited, Jawahar Nagar, Thiruvananthapuram, who are the DGS&D Rate Contract Holders for the supply of machines valid till 30/11/2014 vide DGS&D Rate Contract read as 2nd paper above. As per the DGS&D Rate Contract read as 2nd paper above cost of one machine as per the DGS&D Rate Contract would come to Rs.12,538/- (Rupees twelve thousand five hundred and thirty eight only) inclusive of all taxes and duties. It has been tentatively decided as a first phase to provide 2 machines each to the 17 Regional Transport Offices in the State.

2. In the above circumstances administrative sanction is accorded for the purchase of 34 numbers of Loose Notes counting machine with UV/MG fake note detection from *M/s* Infres Methodex Limited, Jawahar Nagar, Thiruvananthapuram at a total cost of *Rs.4,26,292/-* (Rupees four lakh twenty six thousand two hundred and ninety two only) inclusive of all taxes and duties @ Rs.12,538/- (Rupees twelve thousand five hundred and thirty eight only) inclusive of all taxes and duties for the use of the 17 Regional Transport

Offices in the State @ 2 per office subject to the terms and conditions as laid down in the DGS&D Rate Contract read as 2nd paper above and the delegation of powers issued as per the G.O. read as 4th paper above. The Joint Transport Commissioner and Secretary, STA, Transport Commissionerate is authorized to place supply orders with the firm and to procure the items as per the terms and conditions in the DGS&D Rate Contract read as 2nd paper above. The firm will supply the machines @ 2 each to the 17 Regional Transport Offices of this department as follows:
