He shall co-ordinate all the activities conducted by various Departments in the district and furnish a detailed action taken report to the Transport Commissioner and Road Safety Commissioner on or before 15.02.2019. The Chairman of all

District Road Safety Councils shall submit the detailed expenditure statement to this office and to Kerala Road Safety Authority with the necessary supporting documents on or before 15.02.2019 and the balance fund if any shall be refunded to Motor Vehicles Department through crossed cheque.

The Chief Engineer, PWD(NH), The Chief Engineer PWD(R&D) and Director, NATPAC are requested to furnish the detailed action taken report on the activities of Road Safety Week on or before 15.02.2019 under intimation to Road Safety Commissioner with detailed expenditure statement and supporting documents. The balance fund if any shall be refunded to Motor Vehicles Department through crossed cheque.

The Police Department is also requested to furnish the detailed action taken report to Motor Vehicles Department under intimation to KRSA.
