Sub: Motor Vehicles Department-Cancellation of Temporary Registration or correction in Temporary Registration-Guidelines issuing of-Reg
Ref: This office letter No.C1/18002/TC/09 dated 16-08-2011

Attention is invited to the above reference. Vide reference cited, you were informed that since Section 55 of the Motor Vehicles Act, 1988 specifically provides provision for cancellation of the Certificate of Registration and the authority issuing temporary registration will be equally competent to cancel it for sufficient cause to substantiate the action or mistake therein. Temporary registration can be cancelled on the following grounds:

1. If the mechanical condition of the vehicle is bad:
2. If temporary registration is obtained by fabricating fake documents, by way of misrepresentation of facts or engine number of chassis number of the vehicle is different from that mentioned in temporary registration certificate as per sub section (5) of Section 55 of the Motor Vehicles Act, 1988:
3. Any other reason which the Registering Authority or Additional Registering Authority satisfies himself seem fit for cancellation.


The following procedures shall be followed for the cancellation of temporary registration

- a. The applicant and the dealer shall jointly apply for cancellation of temporary registration in prescribed form within 7 days after the date of commencement of validity of temporary registration;
- b. Due to reasons (1) or (2) mentioned above, the vehicle shall be inspected
- c. Before proceeding for cancellation both the owner and the dealer shall be given an opportunity to make their representation and shall record the statement in writing by the Registering Authority

It may be noted that the Registering Authority shall record his/her findings and reason for cancellation and rejection of cancellation in writing and also obtain necessary inspection report and other substantial proof for canceling the temporary registration.
