As reported by the VACB Trissur Unit, these forgery and falsification of RC Books are the result of non existance of a system in R.T. Officers/ bub R.T. Officers to verify the authenticity of the particulars of RC books of vehicles owned by the private persons. Hence, the Director VACB has recommended to evolve a system to verify the authenticity of the RC particula rs of Mon-Transport Vehicles also before effecting Transfer of Ownership as in the case of Transport Vehicles.

In this circumstance, all Regional Transport Officers/Joint Regional Transport Officers are directed to insist NOC from the previous Registering Authorities before effecting Transfer of ownership of Non-Transport Vehicles also as in the case of Transport Vehicles, with immediate effect.
