The Transport Commissioner has requested to permit the operation of motor cycles other than those fitted with engine capacity of not exceeding 25 cubic centimetres as contract carriages in the State in order to provide employment to a certain number of people as suggested by the National Development Council and to exempt the said vehicles from the provisions of rules 294 and 295 of the Kerala Motor Vehicles Rules, 1989. Government have considered the request and decided to grant the exemption sought for. The notification is intended to achieve the above object.
