Departmental subject - Item No.1

To consider the proposal regarding the powers to be delegated to the Chairman, Secretary of the STA, Kerala.

Item No.1: Delegation of Powers and functions of State Transport Authority.

The State Transport Authority had in its meeting on 5.8.1989 delegated certain powers and functions to the Secretary, Assistant Secretary and Regional Transport Officer (Nationalised Sector), Trivandrum. In the meeting held on 30.7.1998 it was decided to review the existing delegation of powers. Accordingly, this special meeting was convened. The State Transport Authority decides to delegate the following powers and functions in partial modification of the earlier decision taken on 5.8.1989.

- (a) CHAIRMAN. : 1) Issue of fresh Stage Carriage Permits granted by the STA on double point tax.
- 2) Issue of fresh All India Tourist Omni Bus Permits granted by the State Transport Authority.

- 3) Implementation of inter state agreement executed from time to time for the introduction of new Stage Carriages and Goods Carriage Services on Single Point tax basis.
- 4) Countersignature to fresh Stage Carriage Permits issued by other States.
- 5) Grant and Issue of Temporary Permits to Stage Carriage on Inter State routes.
- 6) Grant and Issue of fresh National Permit to Goods Carriages

- (b) Secretary, State Transport Authority:
- 1) Grant and Issue of Renewal, transfer and variation of inter-state Stage Carriage Permits granted by the State Transport Authority on double point tax basis and replacement of Stage Carriages ~~XXXXXX~~ covered by inter-state Permits.
 - 2) Grant and Issue of Renewal and transfer of All India Tourist Omni Bus Permit granted by the State Transport Authority and replacement of vehicles covered by All India Tourist Omni Bus Permits.
 - 3) Implementation of inter-state agreements executed from time to time for the introduction of new taxi cabs on single point tax basis.

13. Grant and issue of recommendation to Kerala based Goods ~~Carriage~~ Carriages to obtain Extension validity of Permits from other States on single point tax basis in the lapsed vacancies.

14. Issue of authorisation to Tourist Vehicles (Bus)

c) Assistant Secretary, : No powers are delegated to State Transport Assistant Secretary, State Authority. Transport Authority.

d) Regional Transport : Powers already delegated to Officer, Nationalised Regional Transport Officer Sector. (Nationalised Sector) Trivandrum on 5.8.1989 will remain unchanged.
