ORDER

As per letters cited above, the Transport Commissioner submitted proposals for

- 1) Opening of 3 Rural Regional Transport Offices at Attingal, Moovattupuzha and Badagara.
- 2) Opening of 12 Sub Regional Transport Offices.
- 3) Opening of 4 Check Posts.
- 4) Creation of 15 Mobile Enforcement Squads.
- 5) Purchasing of vehicles, furniture etc.

2. Government have examined the proposals in detail and are pleased to issue the following orders as relaxation of the economy orders in force to be implemented as the first phase:

(i) One Rural Regional Transport Office will be opened with headquarters at Badagara with Immediate effect and two Rural Regional Transport Offices will be opened with headquarters at Moovattupuzha and Attingal with effect from 1.2.2001 with the following strength for each of the offices,

1. Regional Transport Officer	-	1
2. Joint Regional Transport Officer	-	1
3. Motor Vehicle Inspector	-	2
4. Assistant Motor Vehicle Inspector	-	4
5. Senior Superintendent	-	1
6. Junior Superintendent	-	1
7. Public Relations Officer	-	1
8. Head Accountant	-	1
9. L.D.Clerk	-	6
10. Typist	-	2
11. Driver	-	1
12. Attender	-	2
13. Peon	-	3
14. Part-time Sweeper	-	1

(ii) Five Mobile Enforcement Squads with headquarters at Trivandrum, Kollam, Kochi, Trichur and Kozhikode will be formed with immediate effect with the following staff strength.

PCA

- (1) Motor Vehicle Inspector - 1
(2) Assistant Motor Vehicle Inspector- 2
(3) Driver - 1

(iii) Three Cars and four Jeeps will be purchased. Funds available under the Head '5055-800-92-30-Plan' during 2000-2001 will be utilised.

(iv) Furniture at an estimated cost of Rs.10 lakhs (Ten lakhs only) will be purchased by debiting the expenditure to the head of account '2041-00-001-99-05-0E-4 other Items' during the year 2000-2001 subject to availability of budgetary provision.
